Title of IFIB: Canteen Services

Requirement: JWC is seeking contract support to provide Canteen Services on site. The services include both routine operations (permanent staff) and surge requirements (exercise staff).

Type of Contract: Firm Fixed Price (FFP).

Period of Performance: 01 January 2019 – 31 December 2019 with the possibility of 4 (four) 1(one) year option periods (01 January 2020 - 31 December 2023).

Bidding Procedure: Sealed Bidding (Three Envelopes)

Funding: Customer funded. Annual turnover 4-6 million NOK

Classification: NATO UNCLASSIFIED

Issue Date: **09 August 2018**, (target date).

Bid Closing Date: **15 October 2018**, (target date)

Eligibility: Governmental or Commercial entities (1) that originate and are chartered/incorporated within NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within NATO-member nations and (3) that provide the funding for the aforementioned requirement. Companies which have performed similar contracts within the last three years substantially similar in scope to the requirement described in the solicitation. Contractor personnel performing services under the contract must be citizens of a NATO nation and have appropriate professional training and experience in a related field(s).
