**Title of IFIB:** Portfolio, Programme, and Project (P3M) Support Services Contract.

**Requirement:** JWC is seeking contracted service support to provide programme office capability able to provide programme setup, design and delivery expertise including assurance, operating model design advice, integrated master scheduling, risk management and coordination and synchronisation functionality for a complex transformational programme involving a complex stakeholder community.

Operating within a multi-disciplinary organisation, the programme will include lines of effort associated with, but not limited to; Organisational Change, Digital Transformation, Ways of Working, Organisational Values and Operational Excellence. The contracted service is to provide subject matter experts to provide assessments and recommendations, as well as implementation and delivery methodologies.

JWC is seeking to place a framework contract under which tasking orders will be placed using agreed rates throughout the duration of the Contract.

**Eligibility:** Governmental or Commercial entities (1) that originate and are chartered/incorporated within NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc. within NATO-member nations and (3) that provide the funding for the aforementioned requirement. Companies which have performed similar contracts within the last three years substantially similar in scope to the requirement described in the solicitation.

Contractor personnel performing services under the contract must be citizens of a NATO nation. Any contractor personnel who needs access to JWC must possess at least a valid NATO Secret level security clearance.

All contractor personnel must have appropriate professional training and experience in related fields.

**Delivery location(s):** Anticipated majority of work will be carried out on-site at JWC, Stavanger, Norway. Dependent on scope of tasking order, wider team involvement may be based flexibly with ability to provide reach back support to on-site team.
